Explanatory Notes

1. This application form must normally be signed by a proposer who must have been a playing member of the Club for a period of at least 5 years and a seconder who is a current playing member, or the professional. There are a number of exemptions to this requirement and these are set out below.
2. Where the applicant for Cadet, Junior or Colt membership is the child of a member, the requirement for a proposer and seconder shall not apply.
3. Where the applicant for Cadet or Junior membership is not the child of a member, the proposer may be the parent or guardian and the requirement for a seconder shall not apply.
4. Where the application is for Partner membership, nomination by the partner of the applicant shall be sufficient and no seconder will be required. There is also no requirement for the nominator to have been a playing member for any period.
5. Where the applicant for any category of membership is transferring from a reciprocal club, the requirement for a proposer and seconder shall not apply. A letter of introduction or referral from the applicant's reciprocal club must be obtained.
6. Members who sign as proposer or seconder must have personally known the applicant for a period of at least one year.
7. Playing members are only permitted to nominate one person for membership per annum.
8. Applications from persons who cannot furnish suitably qualified proposers and seconders may be submitted.
The application must in this case be accompanied by three written references from people who have personally known the applicant for a period of at least one year.
